

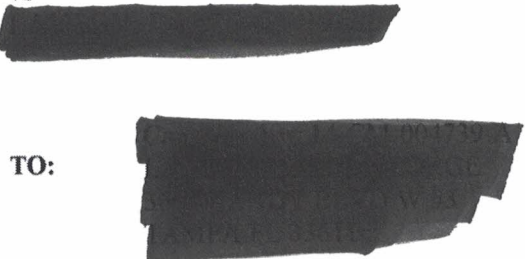

Our records indicate that on the subject case there is currently an outstanding balance of \$270.00. Florida Statute 28.246(6) mandates the Clerk of the Court pursue the collection of any fees, service charges, fines, court costs, or other fees which remain unpaid for 90 days or more. If this outstanding balance is not paid by 04/10/2018, the Clerk will pursue collections through Florida Statute 322.245(5) (a) and/or Florida Statute 28.246(6).

Pursuant to Florida Statute 322.245(5) (a), the Clerk of Court may notify the Department of Highway Safety Motor Vehicles (DHSMV) of your failure to pay financial obligations related to criminal offenses which will result in the suspension of your driver's license.

Additionally, Florida Statute 28.246(6), authorizes unpaid balances to be referred to a collection agent. This will add additional penalties of up to 40% of the amount owed. Liens may be placed against your property, which will add additional fees and interest. You may elect to enroll and participate in a structured payment plan with the Clerk of the Court. Once the unpaid balance has been referred to a collection agent you cannot enroll into a payment plan with our office.
